OHIO DAILY EBOLA CONTACT REPORT

10-20-14, 11 a.m.

COLUMBUS – The Ohio Department of Health reported this morning in its Daily Ebola Contact Report that there are currently:

- 0 confirmed cases of Ebola in Ohio;
- 3 people under quarantine;
- 142 contacts statewide;

ODH's Daily Ebola Contact Report is issued at approximately 11 a.m. and is compiled from the local health districts, ODH officials and Centers for Disease Control and Prevention (CDC) Ohio team members who are working together to identify anyone who may have had contact of some type with the Dallas nurse who was in Northeast Ohio, Oct. 10-13. Symptoms may appear anywhere from 2-21 days after exposure to Ebola, but the average is 8-10 days. It is anticipated that contacts will be removed from the contact list between October 31, and November 4, 2014. The figures may change daily based on the information officials collect on contacts and the type of exposure they may have had.
