Information on the natural hazards that typically affects Ohio has been available through a link on the Ohio EMA Web site for a few years. But now, the Ohio Committee for Severe Weather Awareness has its own Web site for safety and preparedness information. Its address is: www.ocswa.ohio.gov.

Information on the site will be updated at least three times a year. The site includes dates of Ohio's Spring Severe Weather Awareness Week, Lightning Safety Awareness Week and Winter Severe Weather Awareness Week. Also included are links to making disaster plans for the home and for pets; making emergency kits for the home and vehicle; and safety tips for tornadoes, floods, thunder and lightning storms, extreme heat, winter storms and home fires.

It is the committee's goal to inform all Ohioans - young and old - of the weather hazards that most affect the state, and to encourage people to plan and know what to do before, during and after severe weather occurs.

For nearly 30 years, the Ohio Committee for Severe Weather Awareness has been dedicated to educating the public on severe weather safety and preparedness. Committee members represent the American Red Cross; National Weather Service; Ohio Emergency Management Agency; Ohio Insurance Institute; Ohio News Network; Emergency Management Association of Ohio; State Fire Marshal; and the Ohio Departments of Aging, Education, Health, Insurance and Natural Resources.

Ohio EMA Training Goes International

If you regularly attend classes at Ohio Emergency Management Agency, you may have noticed a new face this year. Hyeong-Taek Kang, Ph.D. began taking classes this winter and will be leaving in April.

Kang is a structural engineer with the South Korea Highway Corporation. The South Korean government has sent him to Ohio EMA to study the content of the courses and how we teach the classes. He is one of 14 individuals sent to various states and one to Japan. Because of the different social system in South Korea, the information from the courses in the U.S. is not being used verbatim, but used as an example of how to do things.

Kang is researching how to protect infrastructure in

Korea against natural disasters. Typhoons and flooding are the two major disasters that affect South Korea, however they are concerned with earthquakes as well. National Emergency Management Agency was established in 2004. Kang says there was a form of emergency management in South Korea prior to a devastating 1999 – 2000 typhoon where there was little emergency management experience. With the information gathered from Kang and his counterparts, the Korean government hopes to develop a stronger emergency management structure.

Kang has taken Exercise and Design, Donations Management and the Basic Public Information Officer's course. Over the rest of his time, Kang will be taking other courses offered by Ohio EMA including Debris Management.

"Excellent!" Kang said. "The training I (received) was good. Living here was good. Columbus is a nice place to live."

Kang said he admits he was worried about being in Ohio during the winter, but he is pleased with the unusually warm temperatures we have been experiencing for the most part. However, he did say that the weather changes quickly here.

Don't worry about Kang lugging all the course materials back to Korea. He says he is shipping them back.

While Kang is busy taking classes, his wife and 15 month old daughter wait for him to come home.

Fourth earthquake this year shakes Lake Erie Area

On March 11, Lake County residents experienced their fourth and strongest earthquake this year. The 3.1 magnitude quake started under Lake Erie, three miles north of Mentor-on-the-Lake and approximately 24 miles northeast of Cleveland. Local police said no damage was reported. The Perry Nuclear Power Plant was not impacted by the quake.

Previous earthquakes in the same area occurred on January 5, January 13 and February 10, with magnitudes of 2.0 to 2.6, according to the Ohio Seismic Network.

Salt Fork Lake Dam Update

The Ohio Department of Natural Resources reported that the multi-million dollar repair project at the Salt Fork Lake dam is nearing completion. Water in the 3,000-acre Guernsey County lake will be allowed to rise to its normal level in the next few weeks. Salt Fork is Ohio's largest state park.

The lake's level was maintained about five feet below normal to facilitate repairs on the dam. Repairs were necessary to replace a malfunctioning drainage system discovered early last year in the 1/4-mile long earthen dam. Total cost for the repair project, to include construction, consultants, engineering and materials, totals \$3.2 million.

State Emergency Operations Plan

The updated State of Ohio Emergency Operations Plan (EOP) was delivered to the Office of Governor Bob Taft for review and promulgation.
