

## RECORD OF CHANGES

Changes made to the Ohio Emergency Management Plan are electronically incorporated into the Plan as they are approved. A record of the changes that were made to the Plan since the 2013 Promulgation of the Ohio EOP are listed in the table, below. Dates in parentheses are the years in which updates were made.

<p>Base Plan (2016, 2017) – This plan was updated to account for changes in the operational structure of the State EOC and changes in Ohio’s emergency management environment. A major change to the plan was the replacement of the Crisis Action System language with new Incident Management Structure language for activation of the State EOC – the “Ohio EOC Activation System”. The Base Plan is updated annually.</p>
<p>ESF-1 – Transportation (2015). In the update of this plan, coordinating agencies were added, the Public Utilities Commission of Ohio was added as a support agency to the plan, information regarding the issuing of special permits and waivers was added, and minor adjustments were made to support agencies’ assignments and responsibilities.</p>
<p>ESF-1, Tab A – Medical Countermeasure Transportation and Distribution Plan (2015 and 2017). Significant changes were made to this plan to reflect the capabilities and limitation of state agencies for the transportation and distribution of medical countermeasures from the Strategic National Stockpile and in-state resources.</p>
<p>ESF-1, Tab B – Aviation Support Plan (2013 and 2018). This plan was updated to account for minor changes in the structure and operations of partner agencies.</p>
<p>ESF-1, Tab C – Bridge Collapse Response Plan (2018). Significant changes were made to the plan, including reformatting the plan from a response considerations plan into a plan that follows the State’s standard plan format.</p>
<p>ESF-2 – Communications and Information Technology (2016). This plan was updated to account for changes to the equipment and technology that is available from state agencies and in the State Emergency Operations Center.</p>
<p>ESF-2, Tab A – Warning Plan (2018). Minor changes were made to the plan to bring it into line with standard operating procedures.</p>

<p>ESF-2, Tab B – Cyber Incident Response Plan (2017). This newly-created plan addresses the State’s emergency response to cyber incidents.</p>
<p>ESF-3 – Engineering and Public Works (2013, 2017 and 2018). This plan was updated to account for a small number of operational and assignment of responsibility changes.</p>
<p>ESF-3, Tab A – Debris Management Plan (2013 and 2017). In the update of this plan, changes were made in the Concept of Operations and Assignment of Responsibilities sections. These changes more-accurately reflect how debris response operations are carried out.</p>
<p>ESF-3, Tab B – Water Retention Structure Failure Response Plan (2014 and 2018). Minor changes were made to this plan to discuss the history of dam and levee failures in Ohio, to give a better accounting of the causes of dam failures, and to better align the plan’s concepts of operation with the current operating environment.</p>
<p>ESF-4 – Firefighting (2014 and 2018). A number of changes were made to this plan to more-accurately reflect the operational structure of firefighting response operations. The update of this plan included the review of the ESF’s two Tabs, the Wildfire Plan and the Fire Season Operations Plan.</p>
<p>ESF-5 – Information and Planning (2016 and 2018). A significant number of changes were made to this plan to account for the changes in the roles of the Information and Planning Section’s six Branches – the Intelligence Branch, the Situation and Status Branch, the Field Operations Branch, the Radiological Assessment Branch, the Planning Support Branch, and the GIS/Mapping Branch. Also, the roles of the newly-created Watch Office were defined in the plan.</p>
<p>ESF-6 – Mass Care (2015). Significant updates were done to this plan to more closely define the roles and responsibilities of the plan’s support agencies.</p>
<p>ESF-6, Tab A – Functional Needs Plan (2015). Significant changes were made to this plan to reflect changes in federal-level functional needs definitions and guidance.</p>
<p>ESF-6, Tab B – Emergency Repatriation Plan (2014 and 2017). Changes were made to this plan to be certain that the assignments of responsibility accurately reflect support agencies’ capabilities. This plan was also rechecked as part of a review and update of the Cuyahoga County repatriation response plan.</p>

<p>ESF-6, Tab C – Volunteer Management Plan (2015 and 2018). A thorough update of this plan was done to align the plan with a restructured volunteer management operating concept.</p>
<p>ESF-7 – Resource and Logistics Support (2016). Changes were made to this plan’s Concept of Operations section to reflect changes in how resources will be acquired and distributed. In addition, a resource demobilization section was added to the plan.</p>
<p>ESF-7, Tab A – Donations management Plan (2015 and 2018). A thorough update of this plan was done to align the plan with a restructured donations management operating concept.</p>
<p>ESF-7, Tab C – Emergency Potable Water Procurement and Distribution Operations Plan (2017). This plan was newly-created to outline the operations associated with the procurement and distribution of potable water in response to a public water supply outage.</p>
<p>ESF-8 – Public Health and Medical Services (2016). A significant number of changes were made to this plan to account for the addition of the Coordinating Agency role, and to align the plan’s assignments of responsibilities to the plan’s support agencies’ capabilities.</p>
<p>ESF-8, Tab A – Ohio Medical Countermeasure Management and Dispensing Plan (2015 and 2017). Major changes were made to this plan to reflect changes in how Ohio addresses the receipt, storage and distribution of federal-level and in-state medical caches in response to localized and wide-spread medical emergencies.</p>
<p>ESF-8, Tab B – CHEMPACK Plan (2015). Minor wording changes were made to this plan.</p>
<p>ESF-8, Tab C – Human Infectious Disease Incident Plan (2014). Minor changes were made to this plan to account for changes in the roles of the plan’s support agencies.</p>
<p>ESF-8, Tab D – Acute Mass Fatalities Incident Response Plan (2016 and 2017). An “administrative update” of this plan was initiated by the Ohio Department of Health to account for changes in the capabilities of the State to respond to mass fatality incidents, and to prepare the plan for a mass fatality incident response exercise in 2017.</p>

<p>ESF-8, Tab E – Non-Acute Mass Fatalities Incident Response Plan (2016 and 2018). An “administrative update” of this plan was initiated by the Ohio Department of Health to account for changes in the capabilities of the State to respond to mass fatality incidents, and to prepare the plan for a mass fatality incident response exercise in 2017.</p>
<p>ESF-8, Tab F – Mass Casualties/Medical Surge Incident Response Plan (2016). A moderate number of changes were made to this plan to account for changes in the capabilities of support agencies to respond to and address mass casualty incidents.</p>
<p>ESF-9 – Search and Rescue (2015). Major changes were made to this plan to account for changes in the search and rescue operational environment.</p>
<p>ESF-10 – Oil, Gas and Hazardous Materials (2018). This plan underwent extensive changes in 2018, including the addition of oil and gas functional responsibilities and the deletion of sections that addressed weapons of mass destruction.</p>
<p>ESF-10, Tab A – Radiological Emergency Preparedness (REP) Plan (2013, 2016, 2017 and 2018). The focus of the development and subsequent update of this plan was to refine the plan after the previous-years total restructuring from a stand-alone document to an Ohio EOP element. In the previous-year’s restructuring, information from the existing REP plan was analyzed and it was divided into three documents: the Ohio EOP, the REP Incident Annex, and a newly-created REP Operations Manual. The information that was moved from the REP Plan to the Ohio EOP covers general emergency response actions.</p>
<p>ESF-11 – Agriculture (2013 and 2017). Minor changes were made to this plan to more-accurately reflect the operational structure of response.</p>
<p>ESF-11, Tab A – Animal Disease Incident Plan (2016). A minor update was done to this plan to account for changes in titles of positions that would be engaged during response.</p>
<p>ESF-11, Tab B – National Veterinary Stockpile Plan (2015 and 2018). A small number of changes were made to this document. This document was the subject of a tabletop exercise in 2017 and a full-scale exercise in 2018.</p>
<p>ESF-11, Tab C – Dangerous Wild Animal Response Plan (2013 and 2017). This plan was newly created to respond to the need for a plan that addressed the management of</p>

dangerous wild animals that are held by private parties.
ESF-12 – Energy (2013 and 2017). A moderate number of changes were made to this plan to accurately reflect changes in the operational environment for utility-related response concerns.
ESF-13 – Law Enforcement (2013 and 2017). A minor number of changes were made to this plan to reflect a few changes in operational structure.
ESF-13, Tab B – Correction Facility/Prison Support Plan (2015). A moderate number of changes were made to this plan to better reflect the needs of the Ohio Department of Rehabilitation and Correction and to better define the roles and responsibilities of support agencies.
ESF-13, Tab C – Medical Countermeasure Security Plan (2017). This plan was re-established after previously being removed from the State EOP. This plan addresses management responsibilities for state-level organizations to facilitate security of MCMs when decided that MCMs are required. The primary goal of this plan is to coordinate the provision of security for MCM assets by support agencies during a response that requires delivery of large quantities of medical material throughout Ohio.
ESF-14 – Community Recovery and Mitigation (2013 and 2017). A major re-write of this plan was accomplished by involving support agencies in a process of entering response-related information into an Input Collection Matrix. The information that was received was then compiled into a draft document that encompassed a fuller scope of short- to long-term recovery-related response operations. The 2017 update of this plan entailed a restructuring of the plan to incorporate the federally-created Recovery Strategies, with ESF-14 serving as a response phase directional document and a platform for a link to and the activation of the Strategies.
ESF-14, Tab A – Community Planning and Capability Building (2018). This is one of five newly-created plans that align the Ohio EOP with the federal government’s National Disaster Recovery Framework. This newly-created plan addresses issues that are associated with community planning and capability building.
ESF-14, Tab B – Economic Recovery Strategy (2017 and 2018). This is one of five newly-created plans that align the Ohio EOP with the federal government’s National Disaster Recovery Framework. This newly-created plan addresses issues that are associated with economic recovery in areas that have been impacted by a disaster.

ESF-14, Tab C – Health and Social Services Recovery Strategy (2017). This is one of five newly-created plans that align the Ohio EOP with the federal government’s National Disaster Recovery Framework. This newly-created plan addresses issues that are associated with health and social services recovery in areas that have been impacted by a disaster.

ESF-14, Tab D – Housing Recovery Strategy (2017 and 2018). This is one of five newly-created plans that align the Ohio EOP with the federal government’s National Disaster Recovery Framework. This newly-created plan addresses issues associated with housing recovery in areas that have been impacted by a disaster.

ESF-14, Tab E – Infrastructure Recovery Strategy (2017 and 2018). This is one of five newly-created plans that align the Ohio EOP with the federal government’s National Disaster Recovery Framework. This newly-created plan addresses issues associated with infrastructure recovery in areas that have been impacted by a disaster.

ESF-14, Tab F – Natural and Cultural Resources Recovery Strategy (2017). This is one of five newly-created plans that align the Ohio EOP with the federal government’s National Disaster Recovery Framework. This newly-created plan addresses issues associated with natural and cultural resources recovery in areas that have been impacted by a disaster.

ESF-15 – Emergency Public Information and External Affairs (2014 and 2018). Minor changes were made to this plan to account for changes to the assignments of responsibility for the Lead Agency.

Drought Incident Annex (2016). This Annex was updated after the new State Climatologist assumed his position in 2016 and expanded the operations and responsibilities of the State Climate Office of Ohio.

Terrorism Incident Annex (2013, 2016 and 2018). Significant changes were made to this plan to account for changes in the response environment.

Catastrophic Incident Response Annex (2015). A small amount of changes were made to this plan to account for changes in command and control of tiered response actions that would be employed in a catastrophic incident response.

Tab A to the Catastrophic Incident Response Annex – Improvised Nuclear Device Response Plan (2105 and 2018). This newly-created plan provides state agencies with guidance and response recommendations in the event of a nuclear detonation and to assist and coordinate with all levels of government and the private sector.

Tab B to Catastrophic Incident Response Annex – Catastrophic Resources Management Plan (2016 and 2018). A small number of changes were made to this plan to align it with the capabilities of the plan’s support agencies.
